

## Techboard Report reveals over \$665M in funding for September quarter

This funding report only includes funding events (including equity, debt, acquisition, and grants) confirmed in the September 2017 quarter, involving startups and young tech companies which are <u>eligible for a listing</u> on Techboard. Data is collated by the Techboard team from public sources and through its relationships with investors, VCs and angel groups across the country. 

Over 130 Australian startups and young tech companies raised over \$665m in funding in the September quarter. Half of this was raised in Queensland, though the proportions are skewed by a NAB \$300m debt facility for NEXTDC. Excluding this one deal, NSW actually raised more than any other state, with \$190m flowing to over 50 companies, with venture capital the dominant source.




In contrast, WA's main source of funds was the ASX, with five share placements, two IPOs and a reverse take-over netting over \$37m for local startups.

In addition, Perth startup <u>Power Ledger</u> launched the country's first Initial Coin Offering at the end of the quarter. The solar energy trader raised \$17m in a pre-ICO event and went on to raise a further \$17m in the ICO, though this latter amount was excluded from our report as it closed only last week.



Victorian startups raised roughly the same amount through the ASX as through venture capital, with fintech the dominant sector. Online lender <u>Banjo</u> received a \$20m revolving loan facility from The Aura High Yield SME Fund, and <u>Study Loans</u> and <u>Bitcoin.com.au</u> raised \$2m and \$0.8m respectively.



Average valuations, where disclosed, were \$4.2m nationally, though significantly higher in WA (\$17m) due to a higher proportion of ASX driven deals. Pain recognition startup <u>ePat</u> and logistics platform <u>Yojee</u> both raised funds through share placements at valuations above \$20m. The highest disclosed valuation nationally was <u>Thinxtra</u>'s \$46m valuation. The two year old Internet-of-Things startup secured \$10m from the Clean Energy Innovation Fund as part of a Series B raise, and is also


backed by NZX-listed tech company Rakon Limited. The only other startup valued above \$20m was Victorian 3D printing startup Titomic, which raised \$6.5m in an IPO.

IT hardware made up just over \$300m of funding, though this was driven by NEXTDC's \$300m debt facility from NAB. While NEXTDC is an ASX200 listed company and one of the country's largest data centre operators, it is included in Techboard's scope as it is only 7 years old and remains a fast-growing young tech company.


Fintech made up another \$100m of funding, which was up on the previous quarter if we exclude ZipMoney's \$260m debt facility (coincidentally also led by NAB) in the June quarter. Again most of that money went to NSW companies, with a further \$40m going to ZipMoney in a share placement with Westpac, and Prospa's \$20m in venture debt from US-based Partners for Growth. Another \$10m of venture capital went to NSW startups Brighte, Spriggy, EFTsure and Macrovue.

Telecom companies also put in a strong showing, with a \$20m share placement for Queensland based <u>Superloop</u>, and the acquisition of South Australia-based internet provider <u>NuSkope</u> by Superloop. In Victoria, call recording startup <u>Dubber</u> raised \$7m in an over-subscribed placement.


In addition to NuSkope, six other acquisitions were recorded, with <u>Infoscope</u>, <u>SMG</u> <u>Technologies</u>, <u>OpenLearning</u>, <u>Tapit</u> and <u>Babyology</u> all acquired during the quarter, and <u>ServTech</u> <u>Global offloading its rent toll business</u>.




Government grants predominantly funded CleanTech, Health & biotech and Food & agribusiness startups. Twenty eight grants totalling \$16.6m were recorded, likely only a fraction of the overall activity. The bulk of this came through the federal government's Accelerating Commercialisation program (\$5.9m), the Australian Renewable Energy Agency (\$4.8m) and various state programs like the New South Wales Medical Devices Fund and South Australia's Investment Attraction Agency's Economic Investment Fund.



In contrast, venture capital and venture debt focussed on Fintechs and Marketplaces, with <u>Partners for Growth(Prospa)</u> and <u>Alium Capital (Bitcoin.com.au</u> and <u>Spriggy)</u> active in the former, and <u>AirTree Ventures (Expert360</u> and <u>Snappr)</u> in marketplaces. Both Alium and AirTree are Sydney-based, while San Francisco-based Partners for Growth became active in Australia this year, with APAC Managing Director Jason Georgatos now also based in Sydney. Georgatos is in on Techboard's <u>Panel of Experts</u> for New South Wales, as is Rajeev Gupta, a partner at Alium Capital.



Nineteen angel and seed rounds were recorded totalling \$12m, down on the June quarter in number and total amount. Again though this is only a fraction of the overall activity which largely goes unreported - though Techboard continues to expand its network of investors and angel groups to bring more transparency to the space. Perhaps unusually Food & agribusiness made up a large share of these, though this was skewed by a strong appetite (pun intended) for food and drink startups on Shark Tank. Andrew Banks committed \$2.5m to coffee capsule company iCapsulate (a show record) at a \$11m valuation, Janine Allis put \$300k into Be Fit Foods, and the two sharks combined to commit \$200k to Sweet Mickie, a custom cookie startup. Shopping preferences startup Brauz raised \$2.25m from an undisclosed investor, and Perth-based Healthtech startups WellteQ and Kinchip Systems raised \$1.2m and \$700k respectively.
